OF

In compliance with the requirements of F.S. Chapter 607, undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Article of Incorporation for the purpose of organizing a business corporation.

ARTICLE 1

The name of the corporation ("Corporation") is Crane Construction Company, Inc.

ARTICLE 2

The existence of the corporation shall begin immediately effective upon the acceptance of these Articles of Incorporation by the Florida Secretary of State.

ARTICLE 3

The corporation shall indemnify its directors, officers,


employees and agents to the fullest extent permitted by law.
