ARTICLES OF INCORPORATION OF E-Z AUTO CASH INC

PALLAHASSEE, FLORIDA

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of FLORIDA.

ARTICLE I NAME

The name of the corporation shall be E-Z AUTO CASH INC
