Dear Ms. Brown:

I spoke with Sharon Tala of your office on or about December 22, 1995, regarding your rejection of the Articles of Incorporation for the above-referenced corporation because its name potentially conflicted with ASR Construction, Inc.

I advised Ms. Tala that I was confident that the "A" in ASR Construction, Inc., was not used as an article as that term is defined in grammar, but rather as an initial. Using the letter "A" as an initial rather than an article means that ASR Construction, Inc. is not the same name as S & R Construction, Inc. under the Division's name conflict rules.

Ms. Tala advised me that, if I sent a letter to you indicating that I and my clients, S & R Construction, Inc., and its incorporators, were aware of the existence of ASR Construction, Inc., the Division of Corporations would allow the filing of the Articles of Incorporation of S & R Construction, Inc. Therefore, we do so advise you, and I have instructed Juazine of CSC Networks to refile the said Articles of Incorporation with this letter.



