The name of the corporation is JA-RJ, INC.

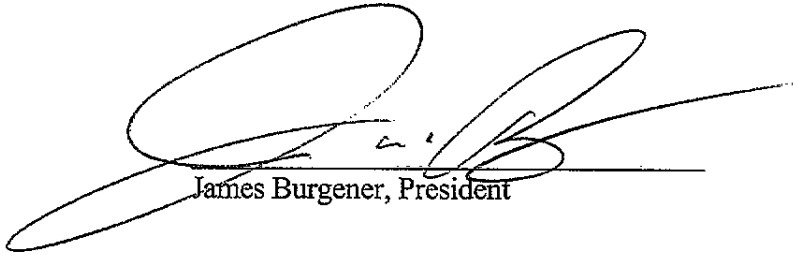
Article II

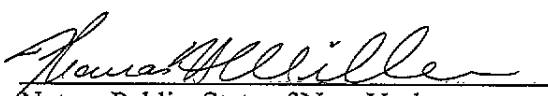
All of the one hundred (100) issued and outstanding shares of the corporation were voted in favor of dissolution.
