SECRETARY OF STATE

The undersigned incorporators, for the purpose of ~~TALLAHASSEE FLORIDA~~ incorporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: YOUR CLEANING SERVICE, INC.






