

**ARTICLE ONE**

The name of the corporation is ALL ABOUT MONEY, INC. The principal office of the corporation is 1226 Forest Wood Drive, Oldsmar, Florida 34677.

**ARTICLE TWO**

The period of its duration is perpetual.

The Board of Directors is empowered to make, alter or repeal the bylaws of the corporation without restriction of their powers conferred by statute.






