Amendment


These Articles of Incorporation may be amended, changed, altered, or repealed only by majority vote of the outstanding common shares.

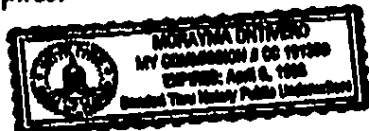
