

ARTICLE I - NAME

The name of this Corporation is Central Florida Framing,
Inc.

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is


