This corporation shall commence January 1, 1996 and



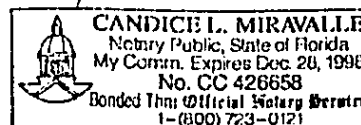
