The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I

Name

The name of the Corporation shall be Orcan Investments, Inc.

ARTICLE II

Principal Office

The principal office of the Corporation is located at 9301 South Orange Blossom Trail, Orlando, Florida 32829, and its mailing address is the same.

ARTICLE III

Corporate Purposes, Power and Rights
