The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is **RAINBOW PAINTING & REMODELING, INC.**

ARTICLE TWO

upon the shareholders is subject to this reservation.




