The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida Business Corporations Act.

ARTICLE I
Name of Corporation

The name of the corporation is:

RECREATIONAL FACTORY WAREHOUSE OF RALEIGH, INC.

ARTICLE II
Commencement of Business

The existence of the corporation will commence upon filing.

ARTICLE III
Purpose

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV
Capital Stock

The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is one hundred thousand (100,000) shares of Common Stock, par value \$.01 per share. The consideration to be paid for each share shall be fixed by the board of directors, and such consideration may consist of any intangible or tangible property or benefit to the corporation, with a value, in the judgment of the board of directors, deemed appropriate.

ARTICLE V
Term of Existence

This corporation is to exist perpetually.

ARTICLE VI
Principal Place of Business

The initial street address in this state of the principal office of this corporation is 3033 Mercy Drive, Orlando, Florida 32810. The Board of Directors may, from time to time, move the principal office to any other address in Florida.


ARTICLE IX


**CERTIFICATE OF DESIGNATION
