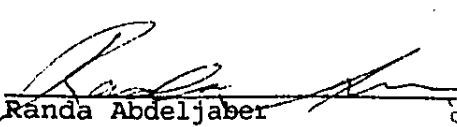

A. The name of this corporation prior to the effective date of these Articles of Amendment was JENINE, INC., Article Number P96000002620.

B. That the Amendment to the Articles of Incorporation is:

1. That Article I of the Articles of Incorporation shall be amended to change the name of the corporation to JENINE'S WAY, INC.

C.
