ARTICLES OF INCORPORATION

OF

LA MIA LAUNDRY, INC.



The undersigned, for the purpose of forming a corporation under the Plorida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is LA MIA LAUNDRY, INC., and its address is: 1601 N.W. 29th Avenue, Miami, Florida 33142.

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

Purpose

The general purposes for which the corporation is organized are:
