ARTICLES OF INCOMPORATION

OF.

ACCOUNTING SOFTWARE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is Accounting Software, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on January 2, 1996.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all business permitted under the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK
