To Whom It May Concern:


Please find the enclosed reinstatement document, along with my check for \$300.00, to cover annual fees for filing of Uniform Business Reports for the years 2002 and 2003. *This is formal request for waiver of the reinstatement fee, as the form to file an annual report for 2002 was not received.* I recently discovered the Admin Dissolution performed on 10/04/2002. While doing some unrelated research on Sunbiz.org, my wife checked on Richard Bercini, P.A. The information we learned prompted her to contact the Division for more information.

As a self-employed independent contractor, I dutifully fill out and file a number of forms related to federal, state, local, and licensure offices on a quarterly an/or annual basis. To be honest, it can be pretty confusing, so I initially checked my files for the missing 2002 Annual Report. I then noted that, *according to the Division's Records*, none of the three possible addresses listed are accurate. The Principal Address is incomplete, *the Mailing address is non-existent*, and the registered agent address is no longer accurate (my home address, which changed in 2001).

*My wife spoke to a helpful employee at the Division of Corporations, who advised my course of action. She explained that the mailing address is what would have been used to send the appropriate forms out, which is why it was never received or filed. She advised that I write this letter, sending it along with the reinstatement form and \$150.00 for last year, along with the \$150.00 currently due.*

Thank you in advance for waiving the reinstatement fees. I appreciate the helpful service my wife received from Division employees during her inquiry, both by email and by phone.
