### ARTICLES OF INCORPORATION

#### OF

## BARDNEY, INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporations:

#### **ARTICLE 1**

The name and mailing address of the corporation are:

#### ARTICLE II

The period of its duration is perpetual.

#### ARTICLE III

The corporation is organized for the purposes of transacting any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
