## ARTICLES OF INCORPORATION

The undersigned subscriber to those Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Figurida.

ARTICLE I.

The name of the corporations shall be:

## ARTICLE II.

The general nature of the business to be transacted by this corporation is:

- (a) Consulting in land purchase and sales.
