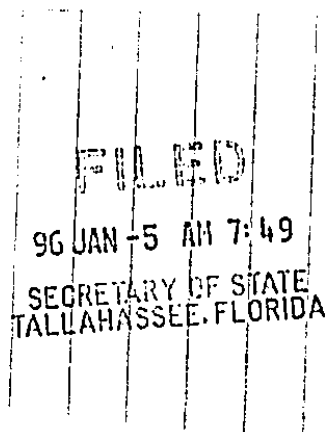

The undersigned subscriber, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of this corporation shall be: LABELLE MOWER & EQUIPMENT CO.
97 Park Avenue, LaBelle, Florida 33935.

ARTICLE II

TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE III

GENERAL PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is: One Hundred (100) shares of common stock having a nominal or par value of One Dollar (\$1.00) per share.

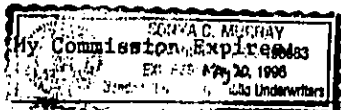

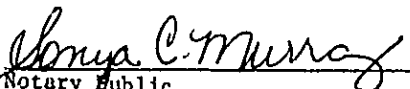
