The undereigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME. The Name of the corporation is: SHAWN RESELT OF STATE OF S

ARTICLE II. DUPATION. The term of existence of the corporation is perpetual.
