We, the undersigned subscribers to these articles of incorporation, natural persons competent to contract, hereby form a Sub Chapter (S) Corporation under the Laws of the State of Florida.

ARTICLE I.

The name of the corporation shall be.

ARTICLE II.

Nature of Business

The general nature of the business to be transacted by this corporation is to repair radio and television electronics and any other activities or business permitted under the laws of the United States and of the State of Florida.

To manufacture, purchase, or otherwise acquire, and to own, mortgage, lease, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in, and with goods, wares, merchandise, real and personal property, and services, of every class, kind and description except that it is not to conduct a banking, telephone or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition.

To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses, in the State of Florida, and in all other state and countries.

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes, and other evidence of indebtedness and execute such mortgages, transfers of corporate indebtedness as required.

To purchase the assets of any other corporation and engage in the same or other character of business.

To guarantee endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities or other evidences of indebtedness created by any other corporation of the state or government, and while owner of such stock to exercise all the rights, power and privileges of ownership, including the right to vote such stock.
