#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is THIRD MILLENNIUM HOLDINGS,

INC. The principal place of business of the corporation shall be 4333 - 2nd Ave. North, St. Petersburg, FL 33713.

SECOND: Pursuant to Section 607.0203, Florida Statutes, the effective date of incorporation shall be January 3, 1996. The period of duration of the corporation is perpetual.

THIRD: The purpose or purposes for which the corporation organized are to engage in any activity or business permitted under the laws of the United States and of this State.

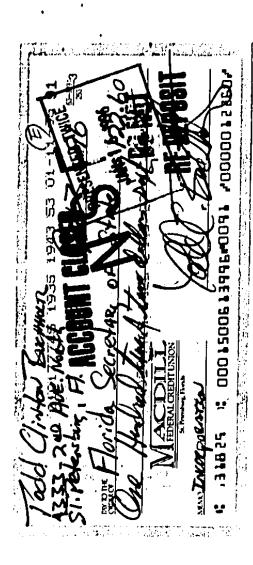
