ARTICLES OF INCORPORATION

We the undersigned, do hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of said State providing for the formation, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be:

ARTICLE II

The general nature of the business and the objects and purposes proposed to be transacted, promoted or carried on are to do any and all of the things hereinafter mentioned, as fully and to the same extent as a natural person could do, viz:

To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.
