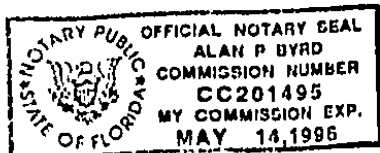

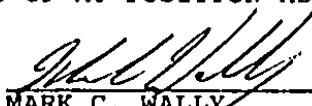
**CERTIFICATE OF DESIGNATION
