## ARTICLES OF INCORPORATION

FOR

J & D Towing III, Inc.

### ARTICLE

NAME and ADDRESS: The name of the corporation is J & D Towing III, Inc. and its principal office and mailing address is 3630 N.W. North River Drive, Miami, Florida 33142.

### **ARTICLE II**

**DURATION:** The term of existence of the corporation is perpetual.

### ARTICLEJII

**PURPOSE:** The purpose of the corporation is to engage in any and all lawful business, including the operation and management of marine equipment.

### ARTICLE IV

CAPITAL STOCK: The aggregate number of shares that the corporation has authority to issue is Five Hundred (500), all of which shall be common shares with One Dollar (\$1.00) par value. The Board of Directors may, from time to time, determine the consideration for all classes and series of shares.

### ARTICLE V

PREEMPTIVE RIGHTS: Each shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which is already held, shall have the right to purchase their pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

### ARTICLE VII

1244 STOCK: The shares of this corporation are to be issued pursuant to the provisions of Section 1244, Title 26 of the Internal Revenue Code.



### ARTICLE YIII
