

ARTICLES OF INCORPORATION OF CARE INVESTMENTS, INC.

PREAMBLE

We the undersigned Subscribers, natural persons, competent to contract, do hereby associate ourselves under the following Articles of Incorporation, and form a Corporation under the laws of the State of Florida.

ARTICLE 1 NAME

EFFECTIVE DATE -1-3-96

The name of the Corporation shall be CARE INVESTMENTS, INC.

ARTICLE II PRINCIPAL ADDRESS AND MAILING ADDRESS

ARTICLE III PURPOSES

REGISTERED AGENT AND OFFICE

The Registered Agent for this Corporation shall be Otto H. Feilen and the Registered Office shall be located at 5970 SW 18th Street, Suite 148, Boca Raton, Florida 33433, or such other person or place as the Board of Directors shall from time to time direct, with appropriate notice being given to the Secretary of State in accordance with the law.

ARTICLE X SPECIAL PROVISO

ARTICLE XI TELEPHONE MEETINGS SUMMARIZED

Members of the Board of Directors or any executive committee designated by the Board of Directors in accordance with the law shall be deemed present at any meeting of the Board of Directors or executive committee, as the case may be, if a conference telephone or similar communications equipment by means of which all persons participating in the meeting can hear and be heard by all other persons is used.


