The difference was that the charge was \$245 and the check was to be made out to AIA CORPORATE SERVICES - 6538 Collins Ave., Ste 451, Miami Beach FL 33141..

On 4/25/06 my book keeper made out the check and sent it to this company. We discovered the problem when they called back and said that I needed to sign a form for them. I questioned how they came to get involved with this and she said, "your payment is now late and they will charge you a \$400 late fee if we don't handle this for you. We have an account with the state."

We have downloaded the form and are sending in the payment of \$150, noting the annual report form notice was not received.

Please contact me if you have additional questions. This company is definitely out to confuse the public in order to make money on State services.
