OF

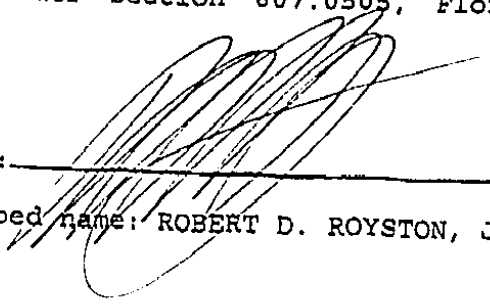
