ARTICLES OF INCORPORATION

OF

CAM FRONT LINE, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE 1

NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is CAM Front Line, Inc.

Section 1.2 Address of Principal Office. The address of the principal office of the corporation is 1890 So. 14th Street, Suite 305, Fernandina Beach, FL 32034.

Section 1.3 Mailing Address. The mailing address of the corporation is 1890 So. 14th Street, Suite 305, Fernandina Beach, FL 32034.

ARTICLE 2

DURATION

Section 2.1 Duration. This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed, except that if they are not filed by the Department of State of Florida within five business days after they are executed, corporate existence shall commence upon filing by the Department of State.

ARTICLE 3

PURPOSES

Section 3.1 Purposes. This corporation is organized for the purposes of transacting any or all lawful business permitted under the laws of the United States and of the State of Florida.

INDEMNIFICATION




