
Pursuant to the provisions of Section 607.1402 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Dissolution for the purpose of dissolving this Corporation:

1. The name of this corporation is CAM Front Line, Inc. (the "Corporation").
2. The dissolution of the Corporation was approved by the Shareholders and Directors of the Corporation on the 11th day of December, 1997.
