The undersigned is licensed to practice medicine in the State of Florida, and acting as the incorporator of a professional corporation under the Florida Professional Corporation and Limited Liability Company Act, hereby adopts the following articles of incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is ERNEST G. HASLAM, M.D., P.A.

ARTICLE II - PURPOSE

The purpose for which this corporation is formed is to engage in the practice of medicine as a professional corporation and to engage in any lawful business activity not inconsistent therewith.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of One Dollar (\$1.00) par value of common stock, which shall be designated "Common Shares".

ARTICLE IV - INITIAL PRINCIPAL OFFICE

AND REGISTERED AGENT
