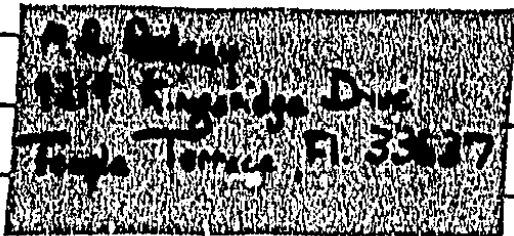

ARTICLES OF INCORPORATION

THE UNDERSIGNED, for the purpose of beginning a Corporation under the laws of the State of Florida, Chapter 607, General Corporation Act, providing for the formation, liabilities, rights, privileges and immunities of a Corporation for profit generally and hereby makes, subscribes, acknowledges and files these Articles for the purpose of becoming a Corporation under the laws of the State of Florida.

ARTICLE I  
NAME OF CORPORATION

The name of this Corporation shall be: *Redcay & Co., Inc.*

ARTICLE II  
GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

1) *To act on behalf of financial institutions and private investors in the purchasing of delinquent real estate taxes.*

2) To carry on any business whatsoever that this Corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interest of this Corporation, and to do all things specified in the Florida Statutes and to have and to exercise all powers conferred by the laws of the State of Florida on Corporations formed under the laws pursuant to which and under which this Corporation is formed, as such are laws are now in effect or may at any time hereafter be amended, and to do any and all things hereinabove set forth to the same extent and as fully as natural persons might or could do, either alone or in connection with other persons, firms, associations, or corporations, and in any part of the world.

The foregoing statement of purposes shall be construed as a statement of both purposes and powers, shall be liberally construed in aid of the powers of this corporation, and the powers and purposes stated in each clause shall, except where otherwise stated, be in nowise limited or restricted by any term or provision of any other clause, and shall be regarded not only as independent purposes, but the purposes and powers stated shall be construed distributively as each object expressed, and the enumeration as to specific powers shall not be construed as to limit in any manner the aforesaid general powers, but are in furtherance of, and in addition to and not in limitation of said general powers.

ARTICLE III  
CAPITAL STOCK

To total number of shares of stock which the Corporation shall have authority to issue is 5,000 shares of common stock with a par value of (\$1.00) dollar per share.

ARTICLE IV  
INITIAL CAPITAL

The amount of capital with which the corporation will begin business is Five Hundred (\$500.00) Dollars.



This corporation shall commence business on the *eight* (8th) day of January, 1996, and the books and records of the corporation shall be kept on a December 31st calendar year end.


