The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I, NAME

The name of the corporation shall be Florida Baseball Camp, Inc. The principal place of business shall be at 11479 Orange Grove Boulevard, West Palm Beach, FL. 33411

ARTICLE II, NATURE OF BUSINESS

This corporation may engage in or transact any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

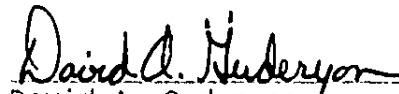
ARTICLE IX, INDEMNIFICATION
