### ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation.

## ARTICLE I - NAME

The name of the corporation is Automatic Payment Systems, Inc.

# ARTICLE II - DURATION

The duration of this corporation shall be perpetual, commencing on the date of execution and acknowledgment of these Articles.

#### ARTICLE III - PURPOSES

This corporation is organized for the following purposes:

- 1) To engage in the business of providing and processing preauthorized checks and the marketing of check drafting services.
- 2) To transact any other lawful business for which the corporation may be incorporated under the Florida Business Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
- 3) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

#### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 10,000 single class shares, of ONE DOLLAR (\$1.00) par value common stock.

#### ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for each of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
