ARTICLE I - NAME

The name of this corporation is LO'L Development, Inc. (the "Corporation").

ARTICLE II - EFFECTIVE DATE/DURATION

The Corporation shall begin its existence or become effective January 5, 1996 and it shall have perpetual existence.

ARTICLE III - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of this Corporation is 1520 Land O'Lakes Boulevard, Suite A, Lutz, FL 33549.

ARTICLE IV - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

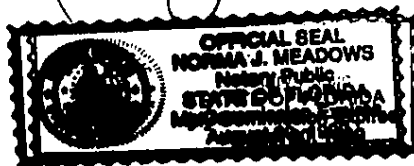
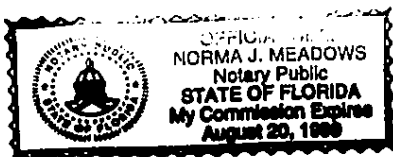
