The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida General Corporation Act.

ARTICLE I

Name

The name of the Corporation shall be Miami Information Authority, Inc.

ARTICLE II

Principal Office

The principal office of the Corporation is located at 2487 Aloma Avenue, Suite 200, Winter Park, Florida 32792 and its mailing address is P. O. Box 1748, Winter Park, Florida 32790.

ARTICLE III

Corporate Purposes, Power and Rights

The purpose of the Corporation is to engage in any activity of business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

Duration of the Corporation

Existence of the Corporation shall commence on the date all fees are paid and these Articles of Incorporation are filed by the Secretary of State and the Corporation shall exist perpetually unless dissolved according to law.

ARTICLE V

Authorized Stock

The total number of shares of capital stock which the Corporation has the authority to issue is 100,000 shares of Common Stock, with a \$0.01 par value per share.

ARTICLE VI

Registered Office and Registered Agent

The street address of the initial registered office of the Corporation in the State of Florida shall be 2487 Aloma Avenue, Suite 200, Winter Park, Florida 32792. The name of the initial registered agent of the Corporation at the registered office shall be Kathryn E. Flickinger.

ARTICLE IV


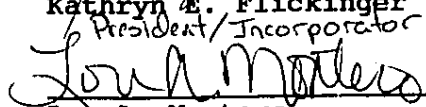
No debt of the corporation remains unpaid.
