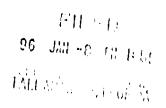

# ARTICLES OF INCORPORATION OF TRU IMAGE SPORTS, INC.



The undersigned hereby makes and subscribes these Articles of Incorporation intending to form a corporation under the provisions of Chapter 607, Florida Statutes.
