ARTICLE I-NAME

The general character, purpose, and nature of business to be transacted by this corporation is to carry on in any capacity and business or trade deemed legal in the State of Florida.


BEFORE ME, the undersigned authority, this day personally appeared Ferdinando Marini, who first by me being duly sworn deposes and says:

1. That affiants are the President, and Vice President and stockholders of Ferway, Inc., who has on the date set forth below changed the officers and elected the following changes


