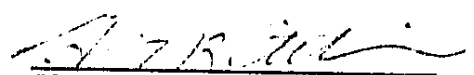

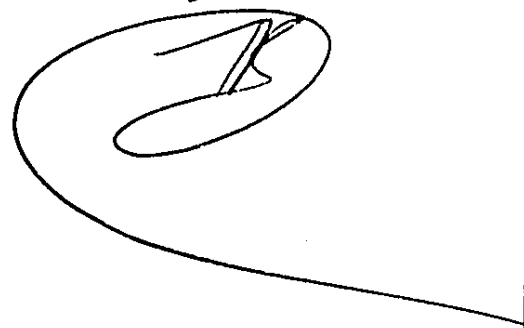

- ARTICLE 1. The name of the corporation is TU-LAWN FINANCIAL CORPORATION.
- ARTICLE 2. The principal place of business and mailing address of this corporation is 408 74th Street, Holmes Beach, FL 34217.
- ARTICLE 3. The duration of this corporation shall be perpetual.
- ARTICLE 4. The general purpose or purposes for which this corporation is being formed, include, but are not limited to the transaction of any or all lawful business permitted under the laws of the State of Florida.
- ARTICLE 5. The corporation is authorized to issue one class of stock, that being 10,000,000 shares of no par value common stock.

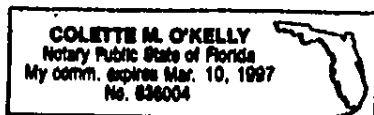
