The undersigned, desiring to form a corporation under the laws of the State of Florida, hereby certify as follows:

FIRST: The name of the corporation is: HEDGE FINANCIAL ADVISORS, INC.

SECOND: The corporate existence of the corporation shall commence upon the filing of these articles by the Department of state and the duration of the corporation is perpetual.

THIRD: The purpose for which this corporation has been formed is to engage in the general business of providing financial services and associated and related services. This corporation may also engage in any lawful business for which a corporation may be incorporated under the laws of the State of Florida. This corporation may exercise any and all powers necessary or convenient to carry out any business in which it may be engaged, and any powers incidental to the carrying out of such business.
