ARTICLE I. NAME

This corporation may engage or transact in any or all



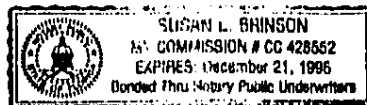
