# ARTICLES OF INCORPORATION

# D & W HOUSING 1, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

#### ARTICLE I

# NAME

The name of the corporation shall be D & W Housing 1, Inc.
