## ARTICLES OF INCORPORATION

OF

## D & W HOUSING 3, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

## ARTICLE I

## NAME

The name of the corporation shall be D & W Housing 3, Inc.
