**ARTICLES OF INCORPORATION**

**OF**

**TOP DAWG CARPET CLEANING, INC.**

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida Corporation Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I  
NAME**

The name of the Corporation is **TOP DAWG CARPET CLEANING, INC.** and the principal place of business is 1325 Olympia Park Circle, Ocoee, Florida 34761.

**ARTICLE II**

The duration of the Corporation is perpetual.

**ARTICLE III**

The general purpose for which the corporation is organized are:

1. To engage in the general business of rug and carpet service and maintenance of all types and description, including shampooing, cleaning, repairing, weaving, re-laying, dyeing, and demoting, and to carry on and conduct any business incidental thereto.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, at the option of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**ARTICLE IV  
CAPITAL STOCK**

The aggregate number of shares which the corporation is authorized to issue is One Hundred Shares (100) stock shares. The par value is \$1.00 per share.






