ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS OSVALDO RODRIGUEZ PAINTING, CORP.

ARTICLE II

DURATION

This corporation shall have a perpetual existence, unless dissolved according to law.

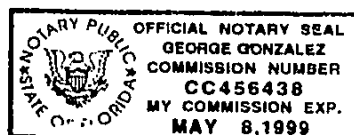

