ARTICLES OF INCORPORATION

KATHLEEN DOYLE, natural person competent to contract does hereby make, subscribe, acknowledge and file in the office of the Secretary of State of the State of Florida for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida, these Articles of Incorporation, as by law provided.

ARTICLE I

The name of this corporation shall be as stated above as SOUTH FLORIDA DIRECT RESPONSE ADVERTISING, INC.

ARTICLE 11 GENERAL NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the Untied States of America and the State of Florida.
