

ARTICLES OF INCORPORATION

OF

ROYAL PAINTING OF CENTRAL FLORIDA, INC.

The undersigned incorporator, being a person competent to continct subscribes to these Articles of Incorporation to form a for profit corporation under the laws of the State of Florida.

ARTICLE I
