**ARTICLE I - NAME**

The name of the corporation is **CRIME PREVENTION TRAINING DIVISION, Inc.** located at 10746 Coral Way, Miami, Florida 33165.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

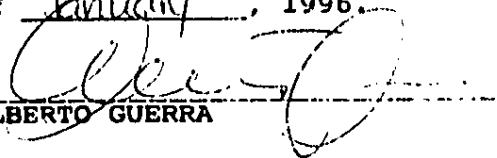
**ARTICLE X - INCORPORATOR**
