**ARTICLES OF INCORPORATION
OF
TECHNOLOGY LEASING CORP.**

In compliance with the requirements of Chapter 607 of the Florida Statutes (the "Florida Business Corporation Act"), the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purposes of organizing a business corporation.

ARTICLE I

The name of the corporation (hereinafter called the "Corporation") is
TECHNOLOGY LEASING CORP.

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The Principal office and mailing address of the Corporation shall be:

ARTICLE III

NATURE OF CORPORATE BUSINESS

The nature of the business and the object and purposes proposed to be transacted, promoted and carried on are to engage in any lawful act of activity for which corporations may be organized under the General Corporation Law of Florida.

ARTICLE IV

TERM OF EXISTENCE

The term of existence of this corporation is perpetual unless sooner dissolved according to law.

ARTICLE V

CAPITAL STOCK

The maximum number of shares which the Corporation is authorized to issue is 1000 shares, all of which shall be Common Stock, each share having no par value. All shares of Common Stock shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI

REGISTERED OFFICE AND AGENT


