The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the corporation is: WEITZNER DEVELOPMENT CORPORATION whose principal place of business is 2031 Main Street, Sarasota, FL 34237.

Article 2. Duration. The duration of the corporation is per-

Article 3. Purpose. The general purposes for which the corporation is organized are the following:
